How we make decisions together: In making decisions, we use a combination of general consent and formal voting procedure. General consent allows the meeting leader to call for objections. If there are no objections, then general consent has been reached and we can move on to the next order of business. If there are one or more objections, then the matter must be put to a formal vote.

To put the matter to a formal vote, we must follow this protocol:

- Raise your hand and be recognized.
- Make your motion.
- Wait for someone to second the motion.
- The chair repeats the motion and asks if there is any discussion about the motion.
- The chair calls the question (vote).

At all times, please raise your hand and wait to be called on before speaking. Please do not repeat the comments of previous speakers. Our time is limited.
